# **Welsh Covid Firebreak Regulations**

The Health Protection (Coronavirus Restrictions) (No. 3) (Wales) Regulations 2020 have been published today 22 October 2020. They come into effect at 6pm 23 October 2020. The regulations will expire at the end of the day 8 November 2020.

Below is a very brief summary.

# Restrictions on Movement and Gathering with Others

No person in Wales may leave their home or gather with people who are not in their household, other than carers, without "reasonable excuse".

The regulations set out examples of what constitutes a reasonable excuse, however this is a nonexclusive list.

#### **Businesses Which Must Close**

Most non-essential businesses will be required to close. We append a list of these businesses to this Briefing.

Businesses are not required to close their online operations.

### **Businesses Subject to Part Closure**

Restaurants, cafés, bars and public houses may only operate as take-away establishments or to provide food and drink to the homeless.

Workplace canteens may remain open if there is no practical alternative for staff to obtain food.

Hotels must close to the public unless they are used as a person's main residence or a person is residing there at 6pm 23 October 2020 and is unable to return to their main residence. Additionally, they may be authorised for use at the request of the Welsh Ministers or Local Authorities.

# Businesses That May Remain Open with Restrictions

Food retailers including supermarkets, convenience stores and off licences, petrol stations and banks are among businesses that may remain open subject to limitations.

There is to be no sale or supply of alcohol for consumption off the premises between 10pm and 6am.

## **Businesses Which Must Close**

- Businesses selling goods or services in a shop including:
  - Homeware stores
  - Nail and beauty salons
  - Establishments providing tanning, massages, piercings, tattooing, electrolysis or acupuncture
  - Auction houses
  - Car dealerships
  - Markets
  - Betting shops
  - Hair salons and barbers
  - Garden centres and plant nurseries
  - Shopping centres and shopping arcades
  - Cinemas
  - Theatres

- Public houses
- Hotels and holiday accommodation including:
  - Holiday sites
  - Camping sites
  - Hostels
  - Bed and breakfasts
  - Other holiday accommodation
  - Places of worship
  - Community centres
  - Crematoriums

#### **Businesses to Remain Open**

- Food retailers including:
  - Food markets
  - Supermarkets
  - Convenience stores
  - Corner shops
  - Establishments selling food or drink for consumption off the premises
- Cafés and canteens in hospitals, care homes, schools or student accommodation
- Prison canteens
